Move-In and Set-up:

-Exhibitor spaces will be available for set-up from 10am until 5pm on Friday March 3rd. Move-in hours will be strictly enforced for security purposes. **ALL EXHIBITORS MUST BE SET UP PRIOR TO 5PM, Friday March 3rd, NO EXHIBITORS WILL BE ALLOWED TO SET UP AFTER 5PM. NO EXCEPTIONS!** *Special arrangements for early arrival can be made by calling the Right Coast office at 800-753-3978.

-Parking/gate passes and exhibitor credentials will be issued when exhibitor arrives to check in at venue. (VENDOR VEHICLES MUST BE PARKED IN DESIGNATED VENDOR PARKING AREAS ONLY)

Vendor Info:

(2 passes - 600sf) (4 passes - 800sf and up)
Additional weekend vendor passes may be purchased at \$10 each.

-Exhibitor display and merchandise must remain within the confines of the contracted space. Distribution of literature and sales aids must take place within your assigned vendor space ONLY.

-Booth space must be used solely by the company/person and for the products and services stipulated in the rental agreement. Subletting of space by exhibitors is strictly prohibited.

-Exhibitors are required to maintain a neat and orderly appearance at all times. Right Coast reserves the right to remove any vendor not selling items described on the front of this application, or deemed not family friendly by Right Coast, Inc. staff.
